

Tell us a little about vourself. How many years have you been teaching?

Kim Kelter Neu: I've been teaching for 25 years and our musical is certainly the highlight each year.

How does your school's performing arts program impact your community?

Our school musical brings together our community, involving over 200 students from both middle and high school. Students make the

sets and the props as well as run the sound control, the lights, play in the orchestra, and, of course, star in the show! Families leave our show amazed at what the students have achieved.

How do you choose shows for your students?

When we choose our show, we always pick something that involves all the students. It must have a chorus and a full orchestra. This limits our choices but allows us to include the most students. We also must keep in mind that our school is grades five through 12, so



whatever show we pick must work for fifth and 12th graders alike. Beauty and the Beast was an easy and perfect choice this year!


What reactions do you expect to see in students when they see their name printed in this Playbill for the first time?



Regionally, he has worked for Actors Theatre of Louisville, Round House, and the Pearl Theatre in New York. He has won six Barrymore Awards for Excellence in Theatre, including the F. Otto Haas Award for an Emerging Theatre Artist. He was named "Best Theatre Talent" by Philadelphia Magazine. Thanks to Mark and Bernard. Love to Jen, Lily & Rita.

JOHNNIE HOBBS, JR. (Hoke Colburn) was an Emeritus Associate Professor at The University of the Arts and received the 2015 Barrymore Lifetime Achievement Award and is a four-time Barrymore nominee. ALFRED UHRY (Author) Alfred Uhry is the only playwright ever to win the Triple Crown: an Oscar, a Tony, and a Pulitzer Prize. He began his career as a lyric writer under contract to the late Frank Loesser. In that capacity he made his Broadway debut in 1968 with Here's Where I Belong. He then wrote the book and lyrics for The Robber Bridegroom and was nominated for a Tony Award. He followed that with five recreated musicals at the Goodspeed Opera House. In 1987 his first play, Driving Miss Daisy, opened at Playwrights Horizons Theatre in New York. It was subsequently moved to the John Houseman Theatre, where it ran for over 1300 performances. The play earned many awards, including the Outer Critics Circle Award and the 1988 Pulitzer Prize for Drama. For the film version, he won an Academy Award and the film itself was voted Best Picture of the Year. Other films include Mystic Pizza and Rich in Love. Mr. Uhry's second play, Last Night of Ballyhoo, which was commissioned by the Cultural Olympiad for the 1996 Atlanta Olympics, opened on Broadway in

February 1997. It has been chosen Best Play by the American Theatre Critics Association, The Outer Critics Circle, and the Drama League, and the 1997 Tony Award. He worked on *Parade*, a musical play about the Leo Frank case, with music and lyrics by Jason Robert Brown and directed by Harold Prince. His film projects include a new adaptation of *Dodsworth* for Time Warner, *Cut Flowers* for Miramax, and *Taft*, commissioned by Morgan Freeman

BERNARD HAVARD (*Director*) It's a great privilege to once again direct Alfred Uhry's timeless play, *Driving Miss Daisy*. Having previously directed a production of this play in Studio 3 with several of these same cast members, this story is one I hold dear. This drama is about unlikely friendship that is both timely and touching. I am blessed with a magnificent cast and designers with whom I am privileged to collaborate. Love to Judy and Brandon. 
SIOBHÁN RUANE (*Director of Production*) This is Siobhán's 11th season at WST. With over 20 years in the business, Siobhán has worked internationally as a Production Manager and Stage Manager. Previously, Siobhán held the faculty position of Stage Management Advisor at Florida State University's School of Theatre. Additional credits include Cirque du Soleil, Norwegian Cruise Line, Cirque Productions, and various regional theatres. Siobhán holds an undergraduate degree from Rutgers University, an MFA from the University of Delaware, and is (proudly!) originally from the Jersey Shore.

BRIAN KURTAS, CSA (Associate Artistic Director) has been associated with WST since 2007. He began his career here as a performer and in the professional apprenticeship program and has since dedicated himself to bringing artists together. He now serves our artists and audiences in the various capacities of casting, directing, programming, and literary management, as his function is to identify the highest quality of artists for our historic theatre. His vision behind unforgettable live experiences and storytelling has become a creative solution from the stage to the screen - he spent 4 seasons as the Executive Producer of Gretna Theatre, has worked on television networks and films including TLC and HGTV, and helped create events and entertainment for brands such as T-Mobile and Walmart while at Live Nation. Originally from Lancaster, Brian is a proud Temple alum and a member of the Casting Society of America.

MARK D. SYLVESTER (*Managing Director*) Mark is proud to be celebrating his 30th season at WST. His extensive career has spanned Summer Stock to Broadway as an actor, stage manager, box office treasurer, theatre manager, marketing and public relations director and general manager. After several years working

with commercial theatre, he has devoted his career to non-profit theatre companies since 1987. To date, Mark has been associated with more than 500 stage productions. An avid collector of musical theatre recordings, his collection contains over 3,500 cast albums from around the world. Widely regarded as a theatrical marketing expert, Mark lectures and consults with organizations internationally. He has served on several boards including seven years with the National Alliance for Musical Theatre where he now holds the honorary position of Board Emeritus and the Advisory Committee of Samuel French, the international play publisher and licensing company. With Bernard Havard he co-authored the book Walnut Street Theatre. Since he joined WST in 1994, it became the most subscribed theatre company in the world.

BERNARD (President HAVARD and Executive Producing/Artistic Director) Vox Populi (The Voice of the People) was written on WST Playbills in the 1800s. Whenever WST has strayed from a populist program, the theatre has gone bankrupt. When I came here 42 years ago, we had no programs and no audience. Today we enjoy one of the largest subscription bases of any theatre in the world. So, my thanks to our loval audience and a warm welcome to newcomers who enjoy and believe in what we do. I admire the artists who dedicated their lives to the theatre and WST, particularly. Our theatre is a non-profit 501-C3 institution, and we rely on contributed income to extend our reach into the community. Last season we reached more than 41,000 students in our city schools. We have 19 esteemed trustees who give their time, wisdom, and contributions to help guide this historical treasure. I came to WST in 1982, and I am as excited now about our future as I was in the beginning. My heartfelt thanks to all who enter this theatre.
